Following is the nomination letter sent by District 35.

As someone who truly exemplifies the word leadership, Brian Kenny is being nominated by District 35 for the 2020 RTOERO Leadership Award.

In various capacities, Brian has held some form of office with RTOERO at both the District and Provincial Levels for over 21 years. Brian has had a second career as a volunteer, doing something that he is sincerely passionate about--helping others.

Immediatley following Brian's retiring from his teaching career, he joined RTOERO District 35 and took on the role of Political Advocay Committee chair. He later became 2nd Vice-President, 1st Vice-President and ultimately, became the President, after which he served as Past President. During the period of his tenure, he went to Senate where he began as an observer and later, as a delegate for a total of four times. Brian's contributions and time were very well received and most imporantly, very much appreciated by all of our members.

Brian was appointed to the Provincial PAC committee where he served for four years, including three as the Chair. In 2004 Brian was elected to the Provincial Executive of RTOERO and served there for six years. Throughout this time, he was also elected twice as President. As a member of the Provincial Executive, he served on all but one of the Provincial Committees. In his role as President, he attended all of the Provincial Committee meetings. In addition, he was able to visit a number of RTOERO Districts in those six years and thoroughly enjoyed seeing how various areas were able to best serve their members. In his capacity as President, Brian went to the Canadian Association of Retired Teachers [CARP] representing RTOERO as a voting delegate.

RTOERO appointed Brian as the Ontario Regional Reprentative to ACER CART which he held for several years before eventually becoming Vice-President, President and currently, is Past President for two-year positions--totaling another six years serving RTOERO and its members. In that role, he went to Ottawa several times to lobby MPs on issues important to retired teachers. He will again be attending this year to lobby for Universal Pharmacare. Following his serving on the Provincial Executive, he was appointed to the Health Safety Insurance Committee [HSIC] Provincial committee for three years.

According to Brian, his 21 years have been "a real labour of happiness." Brian has taught both 'old guard' and 'new guard' retirees the importance of RTOERO, and how valuable volunteer efforts can be for all members. We are extremely fortunate to call him a member of District 35 RTOERO.

Benefits Report

Changes to the BENEFITS PLAN as of Oct, 27, 2020

Pandemic travel coverage

Our travel insurance now covers COVID-19 medical emergencies while travelling, even during the time of government-issued travel advisories. This change is retroactive to Oct. 1, 2020.



Trip cancellation or interruption

Coverage remains in place if you need to cancel or interrupt your trip for any of the reasons on page 73-76 of your Insurance Plans Booklet, including an existing medical condition that has become unstable.

Important note: You are not covered for trip cancellation or interruption related to COVID-19. However, unlike other travel plans, RTOERO will continue to reimburse for cancellations and interruptions unrelated to COVID-19.

Questions and answers

- Q. Why has this change been made to the travel coverage? Does this mean it's safe to travel?
- A. We encourage you to follow government advisories to avoid non-essential travel, as a global travel advisory remains in effect. But we know members may have important reasons to travel, even during pandemic.

Q. Do I have emergency medical coverage if I become ill with COVID-19 while travelling?

- A. Yes. You have emergency medical coverage as long as you did not have any symptoms within 90 days prior to leaving. This coverage applies even during the government's advisory to avoid travel outside of Canada due to the pandemic.
 - Coverage includes, but is not limited to, hospital accommodation, physician charges and prescriptions. Please note that Emergency Air Transportation benefits may be available, when medically required and approved in advance.
 - Contact Global Excel Management using the applicable phone number on your benefits card before starting any medical treatment. For complete details of emergency medical coverage, please refer to pages 50 to 67 of the Insurance Plans Booklet.

Q. My out-of-Canada trip started prior to Oct. 1. Does this new emergency medical travel coverage apply to me?

A. Yes. You are covered for medical emergencies incurred on or after Oct. 1.



Q. If I am out of the country and the Canadian government issues a new advisory related to COVID-19, will I be required to return home immediately?

A. No. You are able to remain in place with COVID-19 emergency medical coverage still in effect.

Q. If I book a trip and become ill with COVID-19 before departing or making additional payments, will I be covered for the cancellation?

A. No. Our travel insurance does not cover trip cancellation or interruption related to COVID-19. However, unlike other travel plans, RTOERO will continue to reimburse for cancellations and interruptions unrelated to COVID-19. Please see page 68-73 of the Insurance Plans Booklet for complete details of trip cancellation and interruption coverage.

Q. If I contract COVID-19 while travelling, am I covered for indirect costs related to my illness?

A. If you are medically unfit to travel due to an emergency, your coverage is extended for up to five days following the date that you are deemed stable to return to your province by your physician or the common carrier.

The coverage provides up to \$250 per day, to a maximum of \$5,000 per trip, per insured person, for the reasonable additional expenses for meals and accommodation, when a trip is extended beyond the last day of the scheduled trip due to the sickness and/or injury suffered by an insured person or travelling companion.

Contact Global Excel Management using the applicable phone number on your benefits card before starting any medical treatment. For complete details of emergency medical coverage, please refer to pages 50 to 67 of the Insurance Plans Booklet.

Q. I received a credit or voucher from my travel provider. Can I claim the full amount through my insurance?

A. You are not eligible to claim amounts that have been reimbursed via refund, voucher or credit. If your credit or voucher expires or a situation arises where you are unable to use it, please contact Global Excel Management at 1-877-346-1467 to review the solutions available to you.

WILLS (and DON'TS)

"I don't need a 'Will'." Some people make wrong assumptions abut who will receive their assets if they die without a 'Will', i.e. 'intestate'. For example, in Ontario married spouses get \$200,000 plus a fractional share, common law partners get nothing.

Even if you are happy with where you think your assets are going, who has authority to pay the taxes, transfer the vehicle, deal with the banks, etc.?

Wills and Power(s) of Attorney ensure that your wishes are carried out as per your direction, otherwise court-appointed administrators will perform these functions and not necessarily according to your wishes nor for the most economical solution. Keep a copy of these documents in a safe place in your residence and be sure to let your Executor know where they are. If it makes you feel more secure, the 'original' documents can be kept in a safety deposit box along with other important documents. Be sure your Executor knows where the key to the safety deposit box is kept.

- Power of Attorney for Personal Care is a legal document in which you name a
 person to make decisions about your medical and other care, when you become
 unable to make those decisions yourself while alive but incapable.
- Power of Attorney for Property is a legal document in which you name a person to make decisions about your money and other assets on your behalf, while you are alive but incapable.

Following are some facts to consider when preparing a 'Will':

- No 'Will' is break free! You can always have people contest your 'Will'. It is very important to talk with your beneficiaries about what you plan to give or not give to them.
- An Executor is not liable for the deceased person's debts.
- Don't go to a Doctor to write a letter saying you are 'sound of mind'. He legally cannot do that. In a court of law, there is no sound of mind accepted. It is better to talk with your Accountant and go over all your assets.
- Do not sign a Power of Attorney, other than the one you make with your Lawyer. Some banks are asking the person to sign on at the bank. Do not do this because it will harm your 'Will' if brought to Probate. Check with your Lawyer if you can give them a copy of the one you made with the Lawyer.
- On-line wills, stationer's wills, and 'will kits' are readily available. Although they are legal, it is very easy to make mistakes and miss important information in your preparation. Use the services of a Lawyer to make sure all the legalities are covered. This will give you peace of mind in knowing that you have taken care of some of the difficult decisions your loved ones would have to make.
